FEMALE OWNER AGREES TO:

- Pay the agreed stud service fee before the Female is serviced.
- Notify **Amanda Crosland of Bella Notte Cavaliers** in writing no later than 60 days after mating if no pregnancy results from the mating. Failure to do so will result in no return service being provided.
- Agrees to perform proper progesterone or there will be no repeat.
- Provide a four-generation pedigree of the Female to be bred.
- Provide documentation of AKC registration.
- Provide documentation of testing results and clearances, such as OFA and DNA screening that is performed on the Female. Include proof that the Female has a clear vaginal culture to protect both the Female and male dog that will be involved in the mating.
- The owner of the Female should be liable for any loss of the stud's future breeding services if the Female owner concealed any health issues.
- Customer agrees to pay all costs associated with completion of breeding; ex: shipping the Female, and/or the collection of semen for insemination, and/or shipping of the semen, etc. In addition to the stud fee. These costs are responsibility of the customer and will not be paid by Bella Notte Cavaliers
- Owner(s) of the Female will be allowed up to 1 repeat breeding if breeding does not take, a total of 2 breeding's. If 2 breeding's are unsuccessful after adequate quality semen is sent, we may ask for documentation to prove the Female is not pregnant at our own discretion. If a litter of 2 or more pups are born and die as a fault of the owner of the dam, Bella Notte Cavaliers will not grant a repeat breeding as it is the owner of the Female's responsibility to take care of the whelping and rearing of the pups. (Please, please take your pregnant Female to the vet on a regular basis while pregnant and get an ultrasound and schedule a C-section if needed, vet visits are vital to a successful pregnancy!)
- Female Dog owner(s) certify that they will not sell offspring from this breeding to any agent, pet store, puppy mill, or individual or agent of any individual, whose purpose is mass production, wholesaling, or retailing of any animal.
- If the payment is in U.S. Dollars, there will be no refund of the stud fee in part or in full- Unless otherwise specified by Bella Notte cavalier. If the payment of the stud fee is choice/pick of the litter (RARE- If this is the case, a following contract will be sent outlining specifics for this occasion), the following conditions are hereby agreed to:



a. This contract shall remain in effect until such time as this Female Dog whelps a live litter b. stud owner(s) have chosen one live puppy as payment for stud services. A live litter shall be considered as two (2) live puppies alive. If all puppies are born dead, or there is only one that survives to seven (7) days old, the stud owner(s) have the right to choose that puppy and Female Dog owner(s) will get a repeat.

RARE- ONLY NECESSARY IF "PICK OF LITTER" IS USED AS STUD FEE PAYMENT

- Female Dog owner(s) agrees to transfer ownership of the chosen pick of the litter puppy to stud owner(s) with properly signed registration papers and no restrictions on registration whatsoever in order to fulfill this contract. Female Dog owner(s) agree that said puppy may bear the name of “ Bella Notte’s (name of dog) ” in the registered name.
- Female Dog owner(s) agree that no puppies from this breeding will be sold until the stud owner(s) have seen the litter, either in person or by photos, and have made their choice of puppy to satisfy the payment.
- If the Female Dog owner(s) live in close proximity where travel to view the litter can be accomplished by either party, the owner(s) of said Female Dog agree to make arrangements with stud owner(s) to allow personal inspection of said litter for choosing pick. If Female Dog owner(s) do not live in close proximity, Female Dog owner(s) agree to send pictures of all the puppies born of the litter at regular intervals, no longer than two (2) weeks between intervals, and agree to contact stud owner(s) prior to sending the pictures , until stud owner(s) have chosen the puppy from the litter, and regular intervals thereafter, agreed to by both parties, until such time as arrangements are made to deliver the pick to stud owner(s). Delivery of said puppy shall be at the expense of the Female Dog owner(s).
- Stud owner(s) reserve the right to have the chosen puppy examined by a licensed veterinarian & Should said puppy be determined to be in ill health, or show any physical defects not readily determined by visual inspection, said puppy may, upon presentation of written diagnosis, be returned to the Female Dog owner(s) for another puppy of equal value from the same litter or subsequent litters, when available, the choice of which to be determined by stud owner(s).
- Female Dog owner(s) agree that the chosen puppy will reside at the home of the Female Dog owner(s), have a fenced yard, if applicable, will not be chained or tethered, and will be provided with proper housing, a good quality diet, all required shots, worming’s, and exercise until delivered to stud owner(s). Puppy will not be delivered until they are at least 8 weeks of age.



STUD OWNER AGREES TO:

- Present a four-generation pedigree of the stud dog mentioned above and provide a copy to the Female owner.
- Provide documentation of testing results and clearances, such as OFA, DNA, and Brucellosis screening that is performed on the stud dog.
- Care for the Female while in his or her charge.
- Sign the Litter Registration once all the fees for the stud service and other expenses related to the breeding of the stud and Female named above.

BREEDING

 - Artificial Insemination (AI)
 - Transcervical
- Fresh Chilled Semen
 - Artificial Insemination (AI)

CONTRACT TYPE

- OPEN (\$2000)
 - Female Owner(s) will receive signed documentation provided by the American Kennel Club to register litter with the AKC
 - Open Breeding right will be given by Stud Owner for the Litter
 - By this contract, it's agreed explicitly that the stud owner is not obligated to process and sign the Litter Registration unless all financial arrangements related to the breeding and the stud fee is paid in full..
- CLOSED/LIMITED (\$1000)
 - Female Owner(s) will receive signed documentation provided by the American Kennel Club for limited registration of litter.
 - NO breeding rights are given for the litter- Female Owner(s) may NOT sell puppies with breeding rights.

The Female will be bred two to three times, whether naturally or artificially. The goal is to make all efforts to cover the whole breeding cycle of the Female dog.

Should it become necessary to enforce any part of this contract by legal means, appropriate attorney's fees, court costs, and all travel expenses will be the responsibility of the owner(s) of the Female Dog. This contract will be deemed a legally binding contract, and is under the jurisdiction of the state of _____, in the county of _____.
