



Puppy Purchase Contract Agreement

PURCHASE CONTRACT:

- Puppies are reserved and held with a deposit of \$_____. Once deposit is received by **Bella Notte Cavaliers** the puppy will be considered sold and marked accordingly.
- Deposits are non-refundable. A deposit will only be refunded in the event of a premature death while in possession of **Bella Notte Cavaliers**. Then and only then can a deposit be refunded. Deposits are non-transferable to future litters, but exceptions can be made under certain circumstances at the discretion of **Bella Notte Cavaliers**. If you decide for whatever reason that you do not want or cannot take your puppy you forfeit your deposit. Seller may select a replacement puppy from the same litter if available or from another litter. If living, the original puppy must be returned to seller at purchasers expense.
- Shipping of puppies is available. ALL SHIPPING COSTS are buyer's responsibility. This cost includes Veterinarian Certificate, Transportation Crate and Actual Shipping Costs. If you need your puppy shipped, the purchase price along with the shipping costs of the puppy must be received by ___(Date)___ the time the puppy reaches six weeks of age. All puppies will be shipped out at ten weeks of age. Flight nanny used for domestic and international flights at purchasers expense.
- Buyers will pick up their puppy ___(Date)__. There will be a boarding fee of \$350.00 per week plus any other expenses if buyer is not able to pick up puppy by ___(Date)__. If puppy is not picked up within two weeks of ___(Date)___ of age or plans are not made by **Bella Notte Cavaliers** and buyer, the buyer than forfeit's the puppy and any deposits and payments made on puppy.
- Under no circumstances will Seller be held responsible for any veterinary or other expenses for any reason whatsoever after the purchase of a puppy.
- Payment options are available through cash, personal check, or zelle. Full payment must be received 2 weeks before puppy is to go home. If picking up in person, no checks will be accepted, only cash.

GUARANTEE

- Seller's goal is always to provide a normal healthy puppy to the purchaser

- **The puppy has a 1-year health guarantee against any hereditary illness.** If there is a hereditary illness a letter from the examining veterinarian stating his/her findings and diagnosis must be sent to Bella Notte Cavaliers. Seller has the option to have the puppy examined by a vet of their choosing. This guarantee does not cover umbilical hernias, which is common in Cavaliers and does not cause a life-threatening condition. umbilical hernias are easily repaired.
- Seller does not make any guarantee as far as size, coat quality, color, temperament, hair length, look of dog, ability to win a show, train, or reproduce.
- Your puppy has been given his/her first round of vaccinations at 9 weeks old . Your veterinarian will likely want to vaccinate your puppy when you take them within 72 hours of coming home. do not let them until your puppy is 13 weeks old. if given too soon it will make your puppy ill or even cause death. If your veterinarian gives your puppy a vaccination before 13 weeks old your one year Health guarantee will be voided.
- Both sire and Dame have OFA clearance. this will reduce risk of progeny developing problems in the future but there is no guarantee. breeder does not guarantee of a passing of hips, external factors like nutrition, rapid weight gain, obesity, lack of exercise, excessive exercise, repetitive strain, and pelvic injuries can cause hip dysplasia in dogs

BUYER AGREEMENT

- Take the puppy to veterinarian with in three business days of receiving the puppy-Health guarantee will be void if not.
- Maintain up-to-date vaccinations and regular routine worming.
- Both parties agree that no dog/puppies have been sold for fighting or any illegal purpose. If buyer is found to be using the pup for illegal purposes or activities, or if the puppy is being abused, kept without adequate food, proper housing or care, we reserve the right to regain possession of the pup.
- buyer agrees to keep the initials '**Bella Notte**' In front of the above purchased dogs registered name for the entire life of the dog- Unless other arrangements have been made between purchaser and seller. this is to show where the puppy was produced.
- The buyer agrees to stay in contact with the seller and inform the seller of any changes in the dog's home such as change of ownership. The buyer also agrees to keep seller posted with updated photos/health of the pup. In the event buyer can no longer provide for, or care for the above said dog, they will contact **Bella Notte Cavaliers** and offer the seller the opportunity to purchase, take possession of him/her back. If **Bella Notte Cavaliers** declines, the buyer may then place the above dog in a home they feel appropriate for the dog.
- **At no time, whatsoever will the seller be held responsible for defects, conditions or injuries caused by buyer's negligence, abuse, improper nutrition or mishandling.**
